Accommodation

The organisation recommends **hotel Benica** (www.benica.cz). This hotel offers 15% discount to our competitors. Discount available for all reservations made till 12 November 2019. No cancellation fee is charged up to 5 days before arrival. The hotel lies nearby the hunting ground. Parking is free of charge. This hotel has further a good parking possibility and green facilities to walk dogs. Their website is also in English.

The hotel must be contacted directly and not through other agents if 15% discount should take its place. An email can be sent to info@benica.cz.

Password for 15% discount: Retriever.

From 24.00 p.m. till 5.30 a.m. the hotel's door will be locked. Otherwise, use the bell at the reception (only if necessary).

Breakfast available from 6 a.m. in the morning.

Dogs can be taken for a walk in the hotel complex. Use the small gate next to the fence to get there. Use dog bags to keep the surrounding clean.

Veterinary conditions:

1. Breeders from the Czech Republic must carry their dog's vaccination certificate (pursuant to Art. 6, Paragraph 3, Item (b) of Act No. 166/1999 Coll. on Veterinary Care and on Amendment of Certain Related Acts) or a pet passport.

All animals over six months of age **must have a valid rabies** vaccination and a certificate of this vaccination pursuant to Art. 4, Paragraph 1, Item (f) of the Veterinary Care Act.

Dogs belonging to breeders from EU member countries or third countries must comply with the conditions specified by the Regulation of the European Parliament and of the Council 998/2003 of May 26, 2003.

2. Dogs must be clinically healthy, in good physical condition and must come from a geographical location free of dangerous carnivore affecting infections.

3. Bitches that are in season, in the second half of pregnancy or less than fifty days after whelping will not be admitted to the trial. Proof of identity is necessary for a further procedure.

4. There is a vet on standby in case of emergency.

General conditions:

1. The dogs must be older than 18 months and 1 day.

2. The entry is open to all retriever breeds.

3. The trial will be judged according to the international regulation for field trials for retriever breeds (English way), approved by the FCI General Committee in Rome, April 2011.

4. The title CACIT (res.CACIT) can be awarded to a dog who has accomplished a perfect performance of exceptional merit and ended up first or rather second.

5. The title CACT (res. CACT) can be awarded to a dog who has accomplished a perfect performance of exceptional merit and ended up first or rather second within its own breed.

6. The judges can withhold the (R)CACIT and (R)CACT if in their opinion the quality of the work is not good enough.

7. The organiser shall not be liable for any damages caused by the dogs or for a loss or death of a dog during the trial.

8. The dog handler **must have an official pedigree of their dog and the Pet Passport on him/her** with a valid rabies vaccination to present at the meeting. The dog handler must also have **a record of past official national or international trials to show the retrieve from the water** to the judges. If there is no record, the water retrieve will be tested eventually.
9. Handlers must be on time and dressed properly to the occasion.
